On November 14, 2018, Ms. Dearmon moved that the Joint Committee adopt the minutes of September 18, 2018 as presented. Ms. Rhodes seconded. Motion carried without objection.

7. NEW BUSINESS

A. Appointment of Joint Committee Members

The Alabama Board of Nursing appointed Valorie Dearmon, DNP, RN, NEA-BC to serve on the Joint Committee as the designated RN. Her term began October 1, 2018 and expires September 30, 2021. Dr. Dearmon is eligible for re-appointment to a second three-year term.

The Alabama Board of Medical Examiners appointed Julia Boothe, MD, Family Medicine, to serve on the Joint Committee for the term October 1, 2018 through September 30, 2021. Dr. Boothe is eligible for re-appointment to a second three-year term.

B. Botox Cover Presentation

The Joint Committee members were requested to determine whether Botox Injections for chronic migraine can be allowed for certified registered nurse practitioners with documented education, training and experience.

Discussion ensued and members reviewed a proposed specialty protocol for Botox Injections for chronic migraine (attached).

Respective staff representatives will develop final protocol format after consideration by the Board of Medical Examiners on November 15, 2018.

On November 14, 2018, Ms. Rhodes moved that the Joint Committee members approve Botox Injections for chronic migraines be allowed for certified registered nurse practitioners with Documented education, training and experience. Ms. Dearmon seconded. Motion carried without objection.

C. Cover 610-X-5 AP FTE Limits

The Joint Committee members were requested to approve revisions to the following sections regarding changes to Collaborative Practice FTE Limits.

- 610-X-5-.04 Qualifications For Physicians In Collaborative Practice With Certified Registered Nurse Practitioners.
- 610-X-5-.05 Limitations Upon Utilization Of Certified Registered Nurse Practitioners.
- 610-X-5-.15 Qualifications For Physicians In Collaborative Practice With Certified Nurse Midwives.
- 610-X-5-.16 Limitations Upon Utilization Of Certified Nurse Midwives.

On November 14, 2018, The Joint Committee members chose to table this request for further discussion and development and will review at a later date. Additionally, discussed the need to develop a physician power point presentation to explain the expansion and restriction of the Standard Protocol for collaboration.
