6. OLD BUSINESS

A. Advanced Practice FTE Limits

The Joint Committee members were requested to discuss revisions to the following sections regarding changes to Collaborative Practice FTE Limits.

- 610-X-5-.04 Qualifications For Physicians In Collaborative Practice With Certified Registered Nurse Practitioners.
- 610-X-5-.05 Limitations Upon Utilization Of Certified Registered Nurse Practitioners.
- 610-X-5-.15 Qualifications For Physicians In Collaborative Practice With Certified Nurse Midwives.
- 610-X-5-.16 Limitations Upon Utilization Of Certified Nurse Midwives.

On January 15, 2019, The Joint Committee members chose to table this request for further discussion and development until the March 19, 2019 meeting.

B. Collaborative Practice Protocol Management

The Joint Committee members were requested to determine the use/distribution of a PowerPoint to increase physician and CRNP/CNM understanding of the use of the standard protocol in collaborative practice.

Discussion ensued and members proposed ideas which will be considered as respective staff representatives continue developing the final product.

A. Intralesional Injections

A. Reforming America's Healthcare System Through Choice and Competition



11. ADJOURNMENT


Dr. Owens moved for adjournment. Dr. Dearmon seconded. The Joint Committee meeting adjourned at 6:40 pm on January 15, 2019.




