Ms. Benson presented a copy of a letter from the State of Alabama Office of the Attorney General for the Board members to review.

# 3. <u>DECLARATORY RULING REQUEST</u>

Ms. Henley reported that on or about August 19, 2022, Mr. Jeffery Wade Forehand, Director and Professor in the Troy University School of Nursing submitted a declaratory ruling request. He further clarified the nature of the request in an August 25, 2022, email. Troy University School of Nursing seeks to hire Morgan Sewell as a full-time lecturer (nursing faculty) in its Associate Degree Nursing Program. Ms. Sewell has a BSN and ten (10) years of nursing practice experience. She is presently enrolled in a BSN to DNP program at Troy University and is expected to graduate in December 2023. To date, Ms. Sewell has completed forty-six (46) credit hours of graduate-level coursework. Dr. Forehand represents that Ms. Sewell's completed graduate coursework is beyond that of a person who holds an MSN degree. Ms. Sewell's transcripts were included with the request.

Board rules require that nursing faculty hold an "earned graduate degree in nursing or a related health field." Alabama Board of Nursing Administrative Code 610-X-3-.02(6)(c)2.i. Ms. Sewell is currently enrolled in a program that bypasses the Master of Science in Nursing and goes directly to a Doctor of Nurse Practice Degree. Based on a review of Ms. Sewell's specific academic record and relevant degree plans, it appears she has completed all of the master's level coursework required for her DNP, and substantially all of the same or similar coursework which would be required for a master's degree in a similar concentration. Based on this specific analysis, the Board could grant Troy University permission to employ Ms. Sewell as a full-time lecturer in the Associate Degree Nursing program; however, because the requirement is for an earned degree, the Board could require that this approval will only be granted until the conclusion of the expected completion date of Ms. Sewell's DNP. Thus, the Board could determine that the approval is only valid through December 2023, at which time Ms. Sewell must be able to demonstrate that she has been awarded an earned graduate degree in nursing or related health field.

On September 16, 2022, Dr. Dearmon moved that the Board accept Troy University's request for Declaratory Ruling along with following the Alabama Board of Nursing rules. Troy University may employ Ms. Sewell as a full-time lecturer in the Associate Degree Nursing Program through December 31, 2023, so long as Ms. Sewell continues her enrollment in her DNP program and to continue to employ Ms. Sewell in a nursing faculty position on or after January 1, 2024. Troy University must verify that Ms. Sewell has been awarded an earned graduate degree in nursing or related health field. Ms. Seip seconded. Motion carried without objection.

# 4. LOAN DEFAULT REPAYMENT SETTLEMENT FOR SMITH

Ms. Henley reported that Ms. Smith signed an Alabama Loan Repayment Program Agreement in 2018 and failed to comply with the terms of the agreement (did not fulfill the service obligation to work in an Area of Critical Need). Accordingly, the Board demanded repayment of the full amount of the loan (\$15,000.00), together with interest and penalties, for a total of \$31,200.00. Ms. Smith did not repay the loan and the matter was referred to the Attorney General's Office for collection (Alabama Board of Nursing contracted with eh Attorney General's Office for collection of the loans). The Attorney General's Office negotiated a settlement agreement, pursuant to which Ms. Smith agrees to repay \$16,200.00, in monthly payments of \$337.50. The basis for foregoing the remaining \$15,000.00 (which is the 100% penalty), is the extreme disruption in the practice of nursing and medicine associated with the COVID-19 pandemic.

On September 16, 2022, Ms. Buford moved that the Board approve the settlement agreement for repayment on default of Graduate Loan. Ms. Carpenter seconded. Motion carried without objection.

# 5. BOARD MEMBER COMPENSATION

Ms. Benson reported that <u>ABN Administrative Code</u> § 610-X-1-.12, Board Member Compensation, requires the Board to set the amount of daily compensation at each September meeting.

- (1) Each member of the Board shall receive daily compensation as authorized by the Board for each day that the member attends Board meetings or engages in other duties of the Board, including, but not limited to hearings, survey visits, conferences, and other meetings.
- (2) At each September meeting, the Board shall set the amount of daily compensation to be received by Board members for the subsequent fiscal year.

The Board established a daily compensation of \$300.00 per day for FY 2018. Prior to October 1, 2014, the daily compensation was \$161.00 per day. Travel days are not compensated with the daily compensation.

# A. <u>FINAL CERTIFICATION ALABAMA BOARD OF NURSING</u> <u>ADMINISTRATIVE CODE CHAPTER 610-X-6 – STANDARDS OF</u> NURSING PRACTICE

Mr. Ingels reported that the Board staff recommends extensive revision to the rules governing standards of practice to align standards for RN and LPN practice and differentiate standards from scope, as well as clarifying standards for advanced practice. Changes from the proposal: references to practice by masters – and higher – prepared RNs have been stricken.

On September 16, 2022, Ms. Seip moved that the Board approve, as final certification, revisions to Alabama Board of Nursing Administrative Code Section 610-X-6 – Standards of Nursing Practice. Ms. Carpenter seconded. Motion carried without objection.

# B. PROPOSED REVISIONS AND EMERGENCY RULE ALABAMA BOARD OF NURSING ADMINISTRATIVE CODE CHAPTER 610-X-15 NURSE APPRENTICESHIP PROGRAMS

Mr. Ingels reported that in light of comments received from nursing education programs and other stakeholders, Board staff recommends minor revisions to the existing rule relating to the responsibilities of nursing education programs conducting apprenticeship programs.

On September 16, 2022, Ms. Seip moved that the Board approve, as initial submission and emergency rule, revisions to Alabama Board of Nursing Administrative Code Section 610-X-15 – Student Nurse Apprentice Programs. Dr. O'Keefe seconded. Motion carried without objection.

# C. PROPOSED REVISIONS AND EMERGENCY RULE ALABAMA BOARD OF NURSING ADMINISTRATIVE CODE CHAPTER 610-X-3 -.13 NURSE APPRENTICE PROGRAMS

Mr. Ingels reported that in light of comments received from nursing education programs and other stakeholders, Board staff recommends minor revisions to the existing rule relating to the responsibilities of employers and nursing education programs conducting apprenticeship programs.

On September 16, 2022, Ms. Buford moved that the Board approve, as initial submission and emergency rule, revisions to Alabama Board of Nursing Administrative Code Section 610-X-3-.13 – Student Nurse Apprentice Programs. Dr. Dearmon seconded. Motion carried without objection.

# D. <u>FEE SCHEDULE REVIEW RULE ALABAMA BOARD OF NURSING</u> ADMINISTRATIVE CODE CHAPTER 610-X-4-.14 FEE SCHEDULE

Mr. Ingels reported that the Board rules require review of the fee schedule each September. Board staff makes no recommendation for revision of the fee schedule at this time.

On September 16, 2022, Dr. Dearmon moved that the Board affirm Alabama Board of Nursing Administrative Code 610-X-4-.14 – Fees without change. Ms. Seip seconded. Motion carried without objection.

# E. PROPOSED REVISIONS AND EMERGENCY RULE ALABAMA BOARD OF NURSING ADMINISTRATIVE CODE SECTION 610-X-3-.02 STANDARDS FOR APPROVAL

Mr. Ingels reported due to typographical error, a number of sections of the subject rule were renumbered incorrectly, according to the Alabama Administrative Code. Board staff recommends revising the rule to correct the numbering of 610-X-3-.02.

Mr. Nalbach shall maintain an active Alabama RN or LPN license at all times during the period of probation pursuant to this Order, he should immediately notify the Board, in writing, of any change of physical address, mailing address, email address, and phone number(s) and documented complete a course on Role in Managing Assaultive Behavior.

On September 16, 2022, Dr. O'Keefe moved that the Board accept the Consent Order. Ms. Seip seconded. Motion carried without objection. 2. Lefko, Benjamin Scott – RN 1-143536 SSL (Lapsed)

Mr. Lefko signed a Consent Order that would deactivate his multistate license and convert to a single state license and indefinitely suspend his RN license. Mr. Lefko in not eligible for reinstatement of licensure to practice nursing in Alabama until such time as evidence of an unencumbered license in Maine is received in the Board office, he cannot practice nursing in Alabama until Alabama licensure has been reinstated in accordance with the Alabama Board of Nursing Administrative Code, he shall immediately notify the Board, in writing, of any change of physical address, mailing address, email address and phone number(s), payment of the reinstatement of suspended license fee and any other applicable fees and receipt of notice of receipt of Board Order.

On September 16, 2022, Ms. Carpenter moved that the Board accept the Consent Order. Mr. Sapalaran seconded. Motion carried without objection.

3. Willis, Kimberly Nakwisi – RN 1-080692 SSL (Active); 1-080692 CRNP (Active)

Ms. Willis signed a Consent Order that would deactivate her multistate license and convert to a single license and suspend her RN and CRNP license until receipt of documentation of: (a) completion of required evaluations; (b) successful completion of the initial phase of an approved treatment program, if treatment is recommended; (c) receipt of recommendation to return to the practice of nursing; (d) participation in an aftercare program, if treatment is recommended; (e) negative random monthly drug screens; (f) contact information for individual counselor, if recommended; (g) accrual of requisite continuing education contact hours; (h) completion of required courses on Disciplinary Actions: What Every Nurse Should Know, Professional Accountability and Legal Liability for Nurses and Understanding Substance Use Disorder in Nursing, if not deemed in need of treatment, and (i) payment of appropriate fees. Should Ms. Willis be deemed in need of treatment and upon documented completion of the above terms. Ms. Willis RN license will be placed on probation for sixty (60) months with the usual substance use disorder stipulations and she will be required to pay a \$1,000.00 fine. If not deemed to be in need of treatment, Ms. Willis RN license will be placed on probation for twelve (12) months with the usual illegal/illicit stipulations and she will be required to pay a \$300.00 fine. In no event, will this period of suspension extend longer than twelve (12) months past the effective date of this Order. Should such occur, Ms. Willis licensure status will be considered as and listed as revoked.

On September 16, 2022, Ms. Carpenter moved that the Board accept the Consent Order. Mr. Sapalaran seconded. Motion carried without objection.

4. Cunningham, Angela Aurora – RN 1-078708 SSL (Active/Probation); CRNP 1-078708 (Lapsed)

Ms. Cunningham signed a Consent Order that would deactivate her multistate license and convert to a single state license, terminate her May 20, 2022 Board Order and suspend her RN license until receipt of documentation of: (a) completion of required evaluations; (b) successful completion of the initial phase of an approve4d treatment program, if treatment is recommended; (c) receipt of recommendation to return to the practice of nursing; (d) participation in an aftercare program, if treatment is recommended; (e) negative random monthly drug screens; (f) contact information for individual counselor, if recommended; (g) accrual of requisite continuing education contact hours; (h) completion of required courses on Disciplinary Actions: What Every Nurse Should Know and Understanding Substance Use Disorder in Nursing, if not deemed in need of treatment; and (i) payment of appropriate fees. Should Ms. Cunningham be deemed in need of treatment and upon documented completion of the above terms, Ms. Cunningham's RN license will be placed on probation for sixty (60) months with the usual substance use disorder stipulation and she will be required to pay a \$1,000.00 fine.
