III. OLD BUSINESS

A. 2024 Collaborative Practice – Continuing Medical Education Requirement

The Joint Committee considered the ABME's request that the ABN deem CME conducted by the BME to be acceptable to satisfy the ABN's rules, effective January 1, 2024, requiring APRNs in collaborative practice to complete ABN-designated continuing education. There was discussion, during which ABN staff explained that the automated licensure and collaborative practice renewal system would not support accepting courses other than those produced and provided by the ABN.

On November 15, 2023, Dr. Rogers moved that the Joint Committee not recommend approval of the request in light of the information provided by ABN staff. Dr. Weida seconded. Motion carried without objection.

IV. NEW BUSINESS

A. Language Amendment Proposal – Standard Protocols

On November 15, 2023, Dr. Rogers moved that the Joint Committee table the proposed amended language for the CRNP standard protocols for two months and revisit with clarified standard verbiage acceptable by both Boards. Dr. Weida seconded. Motion carried without objection.

B. Critical Care Specialty Protocol – Annual Maintenance Procedures

On November 15, 2023, Dr. Dearmon moved that the Joint Committee approve the revisions to the Critical Care Specialty Protocol required annual maintenance procedures for central venous line insertion, internal jugular and femoral (up to 9F). Dr.

Rogers seconded. Motion carried without objection.

C. Collaborative Practice Applications for Full Review

The applications for 'Full Review,' Items 1-1 & 2-1, include Standard Protocol, Standard Formulary, with/without Remote Locations, and/or Covering Physicians.

On November 15, 2023, Dr. Rogers moved that the Joint Committee approve the collaborative practice agreement for Standard Protocol, Standard Formulary, with/without Remote Locations, and/or Covering Physicians, Item 1-1, as listed on the roster. Dr. Weida seconded. Motion carried without objection.

On November 15, 2023, Dr. Dearmon moved that the Joint Committee approve the collaborative practice agreement for Standard Protocol, Standard Formulary, with/without Remote Locations, and/or Covering Physicians, Item 2-1, as listed on the roster. Dr. Boothe seconded. Motion carried without objection.
