CRNP/ CNM Standard Protocol Grid

Core Duties and Scope of Practice: The CRNP/ CNM may work in any setting consistent with the collaborating physician's areas of practice and function within their population-focused scope of practice. The scope of practice of CRNPs/CNMs is defined as those functions and procedures for which they are qualified by formal education, clinical training, area of certification, and experience.

The CRNP/CNM may perform the core skills and formulary listed on the standard protocol. In addition to procedures within the basic RN scope of practice, the collaborating physician and CRNP/ CNM determine whether a skill/procedure on the protocol is necessary for their collaborative practice site(s). The physician must be qualified to provide medical direction for the procedure. The CRNP/ CNM who lacks current proficiency is responsible and accountable for obtaining sufficient education, guidance, and/or supervision for safe practice before performing a procedure. The CRNP/ CNM should have on file the documented training, education, and competency validation for all of the skills/procedures listed below and agreed upon with the collaborating physician, which include, but are not limited to, the following Standard Skill/Procedure Protocol:
